



Water Rates & Info

Water rates are regulated by the Washington Utilities & Transportation Commission (WUTC).

Whidbey Island systems:

(except Silver Lake & Cedarhearth systems in Oak Harbor)

Metered: \$29.35/month + usage.

Usage 0-500 cubic feet per month: \$2.25 per 100 cubic feet; 501-1000 cubic feet per month: \$3.50 per 100 cubic feet; over 1,001 cubic feet: \$4.50 per 100 cubic feet.

Sea View customers: 1 cubic foot = 7.48 gallons

Ready-to-Serve: \$29.35/month

Non-Metered Flat Rate: \$47.04/month

Olympic Peninsula systems:

(except Diamond Point system in Sequim)

Metered: \$24.00/month + usage.

Usage 0-500 cubic feet per month: \$1.00 per 100 cubic feet; 501-1,275 cubic feet per month: \$2.00 per 100 cubic feet; over 1,275 cubic feet: \$2.95 per 100 cubic feet.

Ready-to-Serve: \$24.00/month

Non-Metered Flat Rate: \$38.46/month

Discovery Bay system:

Metered 5/8": \$46.00/month (up to 500 cubic/feet)

Over 500 cubic feet: \$1.00 per 100 cubic feet

Metered 2": \$65.00/month (up to 1,000 cubic feet)

Over 1,000 cubic feet: \$1.00 per 100 cubic feet

(Rates plus state utility tax.)

Pedersen Family systems:

Metered: \$28.00/month + usage.

Usage 0-500 cubic feet per month: \$1.10 per 100 cubic feet; 501-1,000 cubic feet per month: \$2.00 per 100 cubic feet; over 1,000 cubic feet: \$4.00 per 100 cubic feet.

Ready-to-Serve: \$28.00/month

**Existing rates adopted for 2/1/23 acquisition*

Whidbey Island, Discovery Bay & Pedersen systems are billed bi-monthly: March (Jan/Feb usage), May (March/April usage), July (May/June usage), September (July/Aug usage), November (Sept/Oct usage) & January (Nov/Dec usage).

Olympic Peninsula systems are billed bi-monthly: February (Dec/Jan usage), April (Feb/March usage), June (April/May usage), August (June/July usage), October (Aug/Sept usage), & December (Oct/Nov usage).

Meters are read at the end of the month prior to a billing cycle (end of December for a January billing, etc).

Northwest Water Services systems:

Snohomish & Skagit Counties + Cedarhearth & Silver Lake systems in Oak Harbor)

Metered 3/4": 43.00/month + usage.

Usage 0-668 cubic feet per month: \$1.30 per 100 cubic feet; 669-1,337 cubic feet per month: \$2.40 per 100 cubic feet; over 1,337 cubic feet: \$4.00 per 100 cubic feet.

Metered 1": \$71.67/month + usage.

Usage 0-1,114 cubic feet per month: \$1.30 per 100 cubic feet; 1,115-2,228 cubic feet per month: \$2.40 per 100 cubic feet; over 2,228 cubic feet: \$4.00 per 100 cubic feet.

Ready-to-Serve (vacant lots) 3/4": \$43.00/month

Ready-to-Serve (vacant lots) 1": \$71.67/month

Non-Metered Flat Rate: \$65.90/month

Non-Metered Flat Rate (Skagit River Colony):
\$40.00/month

Metered 3/4": 19.25/month + usage.

Usage 0-461 cubic feet per month: \$5.90 per 100 cubic feet; 462-1,125 cubic feet per month: \$6.20 per 100 cubic feet; over 1,125 cubic feet: \$7.50 per 100 cubic feet.

Metered 1": \$32.08/month + usage.

Usage 0-770 cubic feet per month: \$5.90 per 100 cubic feet; 771-1,879 cubic feet per month: \$6.20 per 100 cubic feet; over 1,879 cubic feet: \$7.50 per 100 cubic feet.

Ready-to-Serve (vacant lots): \$19.25/month

Non-Metered Flat Rate: \$51.52/month

DWSRF Loan Surcharge: \$10.10/month

**Existing rates adopted for 8/19/22 ownership change*

Northwest Water Services systems are billed bi-monthly: March (Jan/Feb usage), May (March/April usage), July (May/June usage), September (July/Aug usage), November (Sept/Oct usage) & January (Nov/Dec usage). Meters are read toward the end of the second month, prior to billing.

The Silver Lake Water system is billed the 20th of the month for the prior two month period in February (Dec/Jan usage), April (Feb/March usage), June (April/May usage), August (June/July usage), October (Aug/Sept usage), & December (Oct/Nov usage). Meters are read in the middle of the month prior to billing.

Aquarius systems are billed on the 20th of each month. Meters are read a couple days prior to billing.
